What are the 2022 title 24 California Solar mandate changes?

The CEC released the 2022 Title 24 California solar mandate changes including new requirements for solar PV, battery storage, and EV charging to encourage the installation of onsite clean energy for new buildings.

Do I need a battery for Title 24?

No batteries are needed if the required energy storage capacity is less than 10 kWh. Title 24 is merciful in that it doesn't require a battery, if the calculated requirement is so small that there would hardly be any value in putting it even on a single-family home.

What is the new title 24 code?

In 2023, the updated Title 24 code went into effect. Previously, it only required that building plans be designed to accommodate the installation of solar in the future. The new code requires that a certain amount of solar actually be installed, along with some amount of battery capacity, in certain cases.

Do I need a title 24 report for a new home?

Title 24 requirements can be triggered with an addition to a home or building an ADU. New home construction requires a Title 24 report. The report will include the requirements for the size of solar system.
