What is the federal government solar battery rebate 2025?

Will a solar tax credit end in 2025?

May 13 update: The House Ways and Means Committee is proposing an end to the residential solar tax credit as part of the reconciliation process. If passed, systems placed in service (i.e., installed and inspected) by December 31, 2025 will still qualify for a 30% tax credit.

What is a federal solar battery rebate?

The federal solar battery rebate takes 30% off the upfront cost and likely moves the financial case for installing a battery into an attractive range for many customers.

When does the solar tax credit expire?

The 30% solar tax credit claimed by homeowners (25D) would be terminated at midnight on December 31, 2025. Homeowners who have their systems installed before the end of the year can still claim this credit against their federal tax liability. The 30% solar tax credit for leases and PPAs (48E) would be available through the end of 2027.

Can I get a solar battery rebate if I already have a battery?

The national Solar battery incentive applies to homes with either new or existing rooftop solar systems. What if I already have a battery? You can still install an additional battery and qualify for the government solar battery rebate if it is at a different eligible property.
