What are Florida solar incentives?

Florida solar incentives include the federal tax credit, multiple tax exemptions, local rebates and loan programs and even net metering.

Does Florida have a solar tax credit?

While Florida doesn't have a state solar tax credit, everyone across the country can take advantage of the federal solar tax credit. Officially called the Investment Tax Credit (ITC), this allows taxpayers to recoup 30% of their total solar panel installation investment when they file their taxes.

Are solar panels tax deductible in Florida?

In addition to the great rebates and incentives above, Florida also offers tax exemptions for solar panel systems. The solar sales tax exemption ensures that you won't have to pay a sales tax on your system, while the solar property tax exemption means you don't need to pay a higher property tax for adding solar panels to your house.

Where can I get a solar loan in Florida?

A handful of cities and towns around Florida offer grants, rebates, or low-interest loans to homeowners that install solar panels, including Boynton Beach, Dunedin, and Tallahassee. Does Florida offer solar tax exemptions? In addition to the great rebates and incentives above, Florida also offers tax exemptions for solar panel systems.

When does the solar tax credit expire?

On July 4, 2025, President Trump signed legislation that eliminates the residential solar tax credit entirely starting January 1, 2026--nearly a decade ahead of its original expiration date. Solar projects typically take several months from consultation to installation, so homeowners considering solar should act quickly to lock in these savings.

Does Florida have a solar loan program?

Floridians who need help financing their solar panel installation have access to the state's Property Assessed Clean Energy (PACE) loan program. Only two other states-- California and Missouri --have this program, which allows you to finance solar installations and pay them back with your annual property taxes.

The federal solar tax credit (ITC) lets you deduct 30% of your installation costs from your taxes. This applies to both equipment and labor, lowering your overall expense.
