How much does a project cost in Italy?

Eligible projects should have an estimated cost of up to EUR 1 million, with the minimum being EUR 30,000. The funds will be drawn from Italy's recovery and resilience plan, with around 40% to be reserved for projects in the regions of Abruzzo, Basilicata, Calabria, Campania, Molise, Puglia, Sardinia and Sicily.

How long does the res scheme last in Italy?

The scheme will run until 31 December 2033. The measure aims to facilitate the integration of renewable energy sources ('RES') in the Italian electricity system. The production of electricity by RES does not always coincide with periods of electricity demand.
