What does the 2024 energy storage order mean for NYSERDA?

The 2024 Energy Storage Order established a statewide goal of deploying 3,000 MW of new bulk energy storage by 2030 and required that NYSERDA submit a draft Implementation Plan that outlines the methods and budget that could be used to achieve the bulk energy storage deployment target.

What is the 2024 energy storage order (ISC)?

The 2024 Energy Storage Order adopted the ISC mechanism described in the Roadmap to help drive investment in bulk energy storage resources. The ISC represents 1 MWh of energy storage capacity that is operational and available on a given day, with units considered either available or unavailable for the entire day.

How can America improve energy storage?

: Increasing America's global leadership in energy storage through a DOE-wide effort led by OE and EERE to develop, commercialize, and use next-generation technologies. : Reducing grid-scale storage costs by 90% within the decade for systems that deliver 10+ hours through a variety of efforts coordinated by the ESGC.
