Who is powin storage?

Big names like Tesla and AES stepped in to help, installing storage at record speed, but so did a little-known firm called Powin. Joseph Lu had founded the Oregon-based company years earlier to import consumer products from China and Taiwan.

Is powin a clean tech company?

Powin was a survivor of the first clean tech boom over a decade ago. The company was taken private in 2018, and it received \$135 million in growth equity in 2022 from investors, including Energy Impact Partners, GIC, and Trilantic Energy Partners. More recently, it secured a \$200 million revolving credit facility from KKR.

Does powin have a revolving credit facility?

The company did not say what spurred the sudden rise in debt, though given its reliance on Chinese LFP cells, tariffs may have played a role.

Why is powin shutting down?

The company's potential closure reflects deep industry challenges stemming from trade policy uncertainty. Powin, one of the world's biggest battery storage integrators, is warning that it may need to lay off nearly 250 employees in Oregon and cease operations by late July, citing "unforeseen circumstances" in the market.
