



Solar battery rebate act

Can act homeowners get a solar battery rebate?

ACT homeowners can combine the Sustainable Household Scheme loan with federal STC incentives or ACT-based rebates like the Home Energy Support Program. Australians may also benefit from the new Federal Solar Battery Rebate, officially launching on 1 July 2025 under the Cheaper Home Batteries Program.

Will Australians benefit from the new solar battery rebate?

Australians may also benefit from the new Federal Solar Battery Rebate, officially launching on 1 July 2025 under the Cheaper Home Batteries Program. This confirmed national rebate will offer up to 30% off eligible battery systems--potentially saving homeowners around \$3,500 to \$4,700 on a typical 10-13.5 kWh setup.

Are you eligible for a solar rebate?

Improve home comfort, save money on energy bills, and reduce your environmental impact with rooftop solar systems, hot water heat pumps, reverse cycle heating and cooling systems, and better ceiling insulation. Eligible homeowners can apply for rebates of up to \$5,000. *Terms and Conditions apply. Check Eligibility

How much does a solar energy rebate cost?

This can provide up to \$5,000 (covering half of your upgrade costs) for things like ceiling insulation, solar panels, and switching from gas to electric. You can combine this rebate with the low-interest loan to reduce upfront costs.

What is a solar rebate or subsidy?

A rebate or subsidy will cover part or all of the upfront cost of buying solar or a battery. Rebate schemes operated by states, territories and local governments sometimes only apply to particular groups of people or types of housing, such as social housing, rental properties or apartments. Eligibility criteria may relate to:

What is a Solar Rebate & Act SHS loan?

For solar customers accessing this rebate, in most cases the system size will be limited to 6.6kW. Special exemptions can apply for larger systems if you have high energy use at the property. If the customer is accessing the rebate & the ACT SHS Loan, the ACT SHS Loan will be capped at \$10K.
